In that case, we determined that a debtor's redemption of her exempt property, which would have extinguished an IRS lien on the property, was a transaction with the bankruptcy trustee rather than with the secured creditor, and that the debtor's redemption of her exempt property did not constitute an adequate protection payment pursuant to § 361(2). As we noted, however, in Chase Manhattan Bank, the sole issue was whether the redemption of the exempt property satisfied the "threatened" application of § 546(b) and its corresponding rule of law. The issue of the burden of proof under § 362(g) was not before us in Chase Manhattan Bank. Rather, our holding in Chase Manhattan Bank was the result of *741 the undisputed fact that the debtor's homestead had been properly abandoned. Under § 554, abandonment of the property relieved the debtor of all interest in the property and extinguished the creditor's secured interest. Had the abandonment not occurred, the creditor would have had a lien on the property pursuant to § 546(b). In other words, the effect of abandonment was to eliminate a foreclosure remedy, not a § 362(a) violation. See In re Anes, 195 B.R. at 789. We did not reach our determination that a secured creditor was without recourse to a § 363(c)(2) adequate protection analysis under the facts of that case without answering the question that was before us, i.e., whether the abandonment of the debtor's exempt property constituted an application of § 546(b). Accordingly, we find that our holding in Chase Manhattan Bank does not preclude the Bankruptcy Court's ruling that the debtors may not substantiate their burden of proof to establish the negative position that the foreclosure sale of their homestead property was completed. After reviewing the record in the light most favorable to the Debtors, we conclude that the Bankruptcy Court did not err in finding that the foreclosure sale of the Debtors' homestead property was not completed and that the Debtors had the burden of proof on this issue pursuant to § 362(g)(2). We reach this conclusion based on the following reasons. First, the Bankruptcy Court's analysis of the evidence in its written findings of fact and conclusions of law, pursuant to Rule 52(a) of the Federal Rules of Civil Procedure and Rule 7052 of the Federal Rules of Bankruptcy Procedure, is thorough and
